

McGrath Corsage Draw

TERMS & CONDITIONS

1. Information on how to enter forms part of the terms and conditions of entry.
2. Eligible participants entering the competition are required to provide their own details as requested.
3. To be eligible to enter, participants are required to purchase a McGrath Foundation corsage on 20th March 2010, complete the entry form and lodge the entry form in the competition barrel at various locations around Rosehill Gardens Racecourse.
4. Incomplete or incomprehensible entries will be ineligible.
5. Entry is open to all permanent residents of Australia.
6. The competition commences on 20th March 2010 at 10:30am (EST) and concludes on 20th March 2010 at 3:30pm (EST).
7. The judges' decision is final and no correspondence will be entered into. Prizes cannot be transferred or redeemed for cash.
8. The draw for the winner will take place on 20th March at approximately 4:30pm (EST) at the front Parade Ring, announced over the PA system and on the giant screen at Rosehill Gardens Racecourse.
