TERMS & CONDITIONS

1. To be eligible to enter, participants are required to attend the Toll Charity Classic Gala Dinner on 20th August 2010 and purchase a raffle ticket.
2. Entrants must complete or receive assistance from a McGrath Foundation Raffle Ticket Seller in completing their contact details in the section provided.
3. Incomplete or incomprehensible entries will be ineligible. Complete entries will include a first and last name, a full address and/or a telephone number, at a minimum.
4. Entrants are not restricted or limited to the number of raffle tickets which may be purchased.
5. Raffle ticket sales will commence on 20th August 2010 at approximately 7:30pm and conclude at approximately 9:15PM local time.
6. 400 tickets will be available for sale at \$50 each.
7. The prize cannot be transferred, exchanged or redeemed for cash.
8. The draw for the winners will take place on 20th August 2010 at approximately 9:45pm, in the Ballroom at RACV Royal Pines Resort, Ross Street, Benowa QLD 4217.
9. If the winner is under the age of 18 years the prize will be awarded to their parents or legal guardians.
10. The McGrath Foundation reserves the right to request the winner to submit their ticket stub as proof of identity and purchase. Proof of identification and entry considered suitable for verification is at the discretion of the McGrath Foundation.
